### A Message From Our Leaders

At The Princess Margaret, we know that the research we do today will save lives tomorrow. Our renowned team of doctors, researchers, and scientists is continuously making ground-breaking discoveries that are improving patient outcomes and saving more lives here in Canada and around the world.

Thanks to our community of supporters, this past year the Foundation raised an incredible \$270 million for life-changing cancer research, education, and care. Every donation helped accelerate the pace of innovation and is helping to give cancer patients more quality time with their loved ones.

The team at The Princess Margaret is dedicated to addressing the most challenging and complex cases of cancer in the country, including bladder cancer, which is the 5th most common cancer in Canada. Yet, bladder cancer has a recurrence rate of 60-70% and is the only cancer in Canada with mortality rates that continue to rise. Throughout this report, you will be inspired by the ground-breaking efforts to revolutionize cancer treatments, including a significant investment by the Peter Gilgan Foundation to establish Canada's largest endowed Chair entirely focused on bladder cancer research. You'll also read the story of Luana Locke, a cancer survivor who has overcome the disease six times thanks to advances in early detection, and the story of Nicholas Fidei and the Cycle Warriors, a Ride to Conquer Cancer team that has contributed a remarkable \$5.5 million over the past decade.

Sowing the seeds for future patient support extends beyond physical care. Many of our patients find the mental health aspects of cancer as difficult to cope with as the physical treatments and subsequent side effects. Over the past year, we launched a number of exciting new initiatives to help improve supportive care for patients and their loved ones, including the expansion of the CALM psychotherapy program across Canada and the introduction of the world's first clinical trials program of its kind focused on supportive care. We are also developing new therapeutic psychosocial approaches, including programs that support the mental health of caregivers, the hidden "backbone" of the healthcare system.

Breakthrough discoveries don't have a true impact until we can put them into practice for our patients. That's why we have launched a new Accelerator Fund to help bring our innovations to market sooner. This fund, the first of its kind at a Canadian hospital, will capitalize on the expertise, infrastructure, and clinical capabilities across UHN to improve the chances of new medicines, therapies and devices progressing successfully from the lab to the clinic. In addition, these innovations will not only improve patient care but also generate strong financial returns to support exceptional research at UHN.

### We took pride in many remarkable research achievements this year. Among the highlights:



Launch of clinical studies that use a DNA blood test on patients to detect genetic material from up to 50 different cancers.



Published work on a new test that can distinguish between different brain cancer types within 10 seconds — research that could help surgeons make personalized treatment decisions in real time.



Completion of a clinical trial with a drug that targets KRAS, a commonly mutated gene in cancer. The trial showed positive results and will help advance treatments for KRAS associated lung and colon cancers.



Uncovering a promising target for treating cancers associated with the MYC protein such as Non-Hodgkin's Lymphomas.

In clinical care, we celebrated many innovations as well, including: the arrival of new surgical robots; the expanded availability of genetic testing for inherited risk; the launch of a UHN centre in artificial intelligence; exciting clinical trials in supportive care; and planning for a future particle therapy facility.

We expanded the Princess Margaret Cancer Care Network, proudly signing agreements with three additional cancer centres — Grand River Hospital, Oak Valley Health's Markham Stouffville Hospital and Newfoundland and Labrador Health Services — who join our existing partner, Southlake Regional Health Centre.

In addition, we hosted cancer leaders from 10 different countries at our inaugural Global Partners' Consultation, unveiled the new Cancer Clinical Research Unit Convergence Centre, opened a new clinic for Head and Neck cancers, and refreshed our Gastrointestinal and Genitourinary Clinics.

We thank and celebrate the dedicated team of staff at The Princess Margaret Cancer Foundation without whom many of these innovations, capital projects and world-leading research would not be possible.

Our immense gratitude to our staff, volunteers and learners; your optimism and commitment make a notable difference to patients, their families, and our colleagues.

### A Bold Investment in Bladder Cancer Research



The Peter Gilgan Foundation is a private family foundation that supports charitable initiatives that build a more healthy, prosperous and sustainable future. With a \$5 million gift to create Canada's largest endowed Chair devoted entirely to bladder cancer research, the Peter Gilgan Foundation will accelerate world-leading research into the early detection and treatment of bladder cancer, a disease which affects over 12,000 Canadians every year and is the fifth most common cancer.

Established in loving tribute to the late Paul Gilgan, the Peter Gilgan Chair in Bladder Cancer Research is a significant step toward improving outcomes for bladder cancer patients.

"Sadly, bladder cancer has a 60-70% recurrence rate and is the only cancer where mortality rates have been steadily increasing in Canada. This is because bladder cancer is often detected late and is severely underfunded compared to other cancers," said Dr. Miyo Yamashita, President and Chief Executive Officer of The Princess Margaret Cancer Foundation. "We are incredibly grateful to the Peter Gilgan Foundation. This gift will fuel innovative research that will transform standards of care for bladder cancer patients in Canada and around the world."

Considered the highest academic honour at a medical institution, the Chair will enable world-leading research that will reshape our understanding of the underlying causes of bladder cancer, thereby leading to more effective ways to detect and treat the disease.

The inaugural holder of this prestigious Chair is respected surgical oncologist, Dr. Girish Kulkarni.

Dr. Kulkarni has been a member of The Princess Margaret team for more than 12 years. He is currently Head of the Division of Surgical Oncology and a surgeon-scientist affiliated with the Department of Surgery, Temerty Faculty of Medicine, University of Toronto. He is also a professor in the Department of Surgery, as well as at the Institute of Health Policy, Management and Education.

"I am honoured to be appointed as the inaugural Chairholder of the Peter Gilgan Chair in Bladder Cancer Research," said Dr. Kulkarni. "Thanks to the generosity of the Peter Gilgan Foundation, we will have the opportunity to explore uncharted territories of bladder cancer research, bring new therapeutics to patients, and improve both survival rates and quality of life for people dealing with this disease."

In most major cancer centres, bladder cancer is often funded and studied alongside other urological cancers, including cancers of the kidney, prostate and the male reproductive system. The Princess Margaret is home to top cancer scientists and clinicians who are dedicated to the analysis and treatment of bladder cancer specifically, which has led to several important firsts in bladder cancer research and treatment.

"Bladder cancer is the fifth most common cancer in Canada, affecting over 12,000 Canadians annually and requires a large and highly specialized multidisciplinary team to deliver excellence in care," said Dr. Keith Stewart, Vice-President, Cancer and Director, Princess Margaret Cancer Program, University Health Network. "This significant gift will help mobilize one of the world's brightest cancer research teams at The Princess Margaret to find new innovative ways to treat this disease, deliver novel therapies with less toxicity and provide an exceptional patient experience."

We are incredibly grateful to the Peter Gilgan Foundation for this visionary gift that will have a profound impact on the lives of hundreds of thousands of bladder cancer patients and their loved ones.

How Leslie is Helping to



During her treatment at The Princess Margaret, Leslie met with the team at The Bhalwani Familial Cancer Clinic. Through their investigation, the team identified that Leslie's cancer contained a mutation in the BRCA2 gene, meaning it was hereditary. This was a surprise to Leslie. "My family did not have a notable history of cancer, except my father who had prostate cancer at 77 years of age, a time when many men develop prostate cancer. He turned out to be the genetic carrier."

This genetic mutation puts Leslie at risk for six other types of cancer, including breast cancer.


The familial tie to her disease highlighted the importance of genetic testing and inspired Leslie

to give back to the Early Detection team. "Early detection gives me and many others hope," said Leslie. "My involvement makes me feel positive about the future."

Leslie decided to leverage her personal and professional experience to become a member of the Patient Advisory Group for Drs. Trevor Pugh and Raymond Kim's CHARM clinical trial. This international study aims to develop a new liquid biopsy – a non-invasive blood test – that can detect tumours in patients with hereditary cancer syndromes. These patients are born with a genetic change that places them at a higher risk for developing many cancers in their lifetime.

Leslie donated \$50,000 to The Princess Margaret in honour of herself, her husband and her two dogs, Kianga and Momoa, whom she adores. She is also setting up a Donor Advised Fund (DAF) to help ensure funding continues for this critical area. "My diagnosis has driven my financial support for The Princess Margaret as well as my decision to make a planned gift through my estate. I will help advance genetic-based research such as CHARM in any way I can."

### Patrick's Legacy Lives on Through The Princess Margaret

Patrick Chung had always been in good health until a routine blood test showed abnormalities. The diagnosis: acute myeloid leukemia, a type of cancer that starts in the bone marrow and quickly moves into the bloodstream. This news came as a shock to Patrick and his family. However, he was determined to get through this difficult prognosis and immediately started chemotherapy.

He then underwent an allogeneic bone marrow transplant at The Princess Margaret, under the care of Dr. Rajat Kumar and the team at the Messner Allogeneic Transplant Program. The program is named after Hans Messner, the renowned Clinician Scientist who was a pioneer of bone marrow transplants in Canada.

Due to the intensity of his treatment, Patrick was isolated for extended periods within the Cancer Centre as an inpatient. It was during one of these extended hospital stays that Patrick decided he wanted to give back to the team that was taking such good care of him. "Patrick felt immensely grateful for the care he received from the doctors and nurses. As an engineer, he understood the importance of research in improving care," said

Winnie Chung, Patrick's wife. He wanted to learn more about Dr. Kumar's research and how he could help improve outcomes for patients like him. He decided to make a gift in support of Dr. Kumar's research within the Messner Allogeneic Transplant Program.

Sadly, Patrick passed away suddenly in November 2023 before he could make his donation, but his family made sure that his wishes were honoured. Through the Chung family's foundation, Winnie and Patrick's brother, Wilfred, generously facilitated a gift of \$50,000 to support cancer research at The Princess Margaret, which is home to the largest and longest-running allogeneic stem cell transplant program in Canada. The program sees some of the most complex blood-based cancers and lifethreatening blood disorders in the country.

## Building a Brighter Future for Lymphoma Patients

n 1961, Drs. James Till and Ernest McCulloch made a groundbreaking discovery that transformed cancer medicine by proving the existence of stem cells. Their research at The Princess Margaret transformed cancer care — not only by spearheading revolutionary treatment methods but by creating some of Canada's first clinical trial programs, including bone marrow transplantation.

To honour their legacy, The Princess Margaret Cancer Foundation launched the Till & McCulloch Society in 2015. This society recognizes individuals, foundations, corporations and unions who have cumulatively donated \$1 million or more. The support of these donors provides critical resources to the world-renowned scientists and clinicians at The Princess Margaret, enabling them to continue making critical advances in cancer research, education and care.

Among the remarkable Till & McCulloch Society members are Lillian and Dr. Stanley Cash, who have generously donated more than \$1 million toward lymphoma research at The Princess Margaret, home to Canada's largest lymphoma research program.

The couple has experienced the devastating effects of cancer firsthand after losing two of their children and their grandchild to the disease. Despite their losses, they were inspired by the unwavering commitment of the Cancer Centre staff and decided to help other patients and their loved ones.

Through their visionary donation, the Cash family's gift will advance investigator-initiated trials, which are custom-designed by clinicians and researchers to meet the needs of patients while answering fundamental questions about specific therapies. This type of research can refine treatments, help find better ways to mitigate side effects or pilot new, even more effective approaches.

"We have worked very hard and been fortunate enough to accumulate money that we can share with the hospital to help people with cancer," said Dr. Cash. "We can open doors by helping ourselves, our family and everyone who is impacted by this horrible disease and that's why we chose to give this gift."

The Princess Margaret is at the forefront of cancer research and treatment, thanks in part to the incredible generosity of Till & McCulloch Society members like Dr. Stanley Cash and Lillian Cash. Their contributions have allowed our clinicians, scientists and researchers to continue to break new ground in the field of cancer care, pushing the boundaries of knowledge and innovation to offer revolutionary, world-class treatment to our patients. We are immensely grateful for their support and unwavering commitment to Conquering Cancer In Our Lifetime.

### Jane's Generosity Knows No Bounds

#### Confidence in The Princess Margaret inspired two legacy gifts.

n 2017, Jane Adams made a startling discovery: a lump the size of a clementine under her arm. Alarmed, Jane visited a same-day care clinic where she was immediately referred to Princess Margaret Cancer Centre's Gattuso Rapid Diagnostic Centre (GRDC) for a biopsy.

The GRDC provides comprehensive personalized breast cancer care by detecting and diagnosing cancer rapidly and precisely. While patients at other hospitals experience the anxiety of waiting weeks or months for a diagnosis, the GRDC team strives to provide results and a personalized treatment plan for patients within 48 hours, the majority within one day.

Jane went to the GRDC on a Thursday morning and returned the next day to receive her results.

She was shocked to learn that not only did she have Stage 3 breast cancer, she also had a second tumour in her breast.

"The ability to start putting a treatment plan in place 24 hours after a biopsy does great things for your soul," said Jane.

After undergoing chemotherapy, surgery and radiation, Jane found her life slowly returned to normal.

Thankful for the care that she received from clinicianscientist, Dr. Philippe Bedard and his team, Jane is leaving a gift in her Will to help advance breast cancer research and expand the GRDC.

"My team at The Princess Margaret demonstrated care and compassion throughout my entire experience," said Jane.

She is now a member of the J.C.B. Grant Society, which recognizes and celebrates donors who have made a bequest to The Princess Margaret as part of their own legacy.

Unfortunately, Jane's journey with cancer continued to unfold.

In August 2022, she began having abnormal headaches, but chalked it up to stress. When the headaches persisted, Jane visited her local emergency department where doctors determined that the headaches were being caused by six brain tumours. Jane's breast cancer had spread.

Jane underwent emergency surgery to remove the largest tumour, and the others were later treated with radiation. Thankfully, one tumour is gone, and the others have not grown.

Jane's cancer care shifted back to The Princess Margaret

— a place where she finds comfort and confidence.

"What I have is treatable but not curable. However, I know I will receive the best possible treatments at The Princess Margaret," said Jane.

Having also recently lost three close friends, all to a rare form of brain cancer called glioblastoma, Jane decided to also support glioblastoma research through her Will.

"Legacy gifts enable life-altering research discoveries that will change the future of cancer. I am determined to help The Princess Margaret to Conquer Cancer," said Jane.

ach year, thousands of passionate supporters come together as a community to raise funds for life-changing cancer research. Every dollar raised helps The Princess Margaret's renowned clinicians, scientists and medical professionals improve patient care and shape The Future of Cancer Breakthroughs.

This year, four of our signature events were recognized as the most successful nationwide and thanks to the dedication of our community, our other events continue to grow. We extend our heartfelt gratitude to every lottery ticket purchaser, event participant, volunteer and donor who united to make a difference in the lives of cancer patients and their loved ones.





The Princess Margaret Lottery is Canada's largest charitable lottery. This year, the program raised over \$150 million. These funds continue to advance life-changing innovations in research at The Princess Margaret. All ticket purchasers have the chance to win incredible real estate prizes, once-in-a-lifetime experiences, cash, cars and so much more.



The Ride to Conquer Cancer continues to be Canada's largest and most impactful cycling fundraiser, having raised over \$280 million since 2008. Each year, thousands of people come together and embark on a transformative, 200+ km cycling adventure. This year, more than 3,400 participants rode from Toronto to Niagara Falls and raised an impressive \$17.3 million.





The Walk to Conquer Cancer continues to be a celebration of hope driven by a community of like-minded dedicated supporters. The annual, 21 km half-marathon challenge is one of our longest-running events. In its 21st year, more than 1,600 participants raised \$3.4 million, the highest fundraising achievement since the onset of the COVID-19 pandemic.



Northern Pass to Conquer Cancer remains Muskoka's premiere cycling event and our fastest growing peer-to-peer fundraiser. This year, we surpassed a bold \$1 million revenue target – our highest number to date! Fuelled by our mission and sustained by the commitment of our community, we eagerly anticipate our return to cottage country in August for another scenic ride.



Road Hockey to Conquer Cancer, fuelled by Longo's, has raised \$33 million over 13 years. This year more than 150 teams and 1,800 players came together and set a new world record for dollars raised through a single-day Road Hockey fundraiser. Journey to Conquer Cancer, presented by Starlight, celebrated a decade of family-friendly fun this year. Once again, participants could walk or run 1 km, 3 km or 5 km. We welcomed a community of over 2,000 participants of all ages and their dogs. We also introduced a new mascot named Hope and reunited with several super groups like MM5K, Head for A Cure and Pancreatic Cancer Canada. Together, we raised a remarkable \$1.3 million.



Quest to Conquer Cancer is a year-round fundraiser that rallies streamers, gamers and content creators from around the world. Participants host charity streams and put their passion for gaming towards Conquering Cancer. This year, we set a record, raising more than \$400,000, bringing the event's cumulative fundraising total to \$1.7 million. With **D.I.Y. to Conquer Cancer,** supporters are able to make a difference in their own personalized way. #### One day at a time, one step at a time.

When patients and visitors step into Princess Margaret Cancer Centre, one of the first people they'll likely see is Kaimraj Dookie. Kaimraj has worked in security at The Princess Margaret for almost three decades and is well-known at the hospital for going above and beyond to make sure everyone who walks through its doors feels safe and cared for.

"At the hospital, we see the pain and suffering that people go through. And as a security guard, you see so many things you can do to help," said Kaimraj. "It touches my spirit to make a difference. This is what my job is all about – if I can make a difference in somebody's life. I will do it."

Kaimraj has gotten to know many patients and families over his 28 years, even receiving thank you cards from some of them. "I come in contact with cancer patients from all walks of life. I hear their stories: I understand their pain."

In February of 2022, Kaimraj's brother Vic was diagnosed with stage 4 stomach cancer and sadly passed away just seven months later. That's when Kaimraj felt he wanted to do something even more.

"The only way I can make a difference is to raise funds in support of stomach cancer so there can be more research done into diagnosing it quicker and finding more ways of treatment."

A regular participant in both the Walk to Conquer Cancer and the Journey to Conquer Cancer, he hopes to raise \$2,000 between the two events this year.

ore than a decade ago, a chance invitation from two friends sparked a fire inside of Nicholas Fidei. "They told me there was a 200 km ride for cancer research, from Toronto to Niagara Falls...and that it was two days away," he remembers. "I didn't even own a bike before that, but the moment we crossed the finish line I knew I had to rally a team for this incredible cause."

The following year in 2012, Nicholas not only joined the Ride to Conquer Cancer again, but he assumed the role of team captain for the small but mighty Cycle Warriors. He and seven others surged out of the gate, raising an impressive \$120,000 during their first two years. While content with the results, Nicholas's entrepreneurial spirit drove him to create his own fundraising incentives to entice the team's potential donors. "One year, we offered our supporters an exclusive chance to win a Fiat 500," he recalled. "It catapulted our fundraising efforts."

Year after year, the team came up with new, innovative fundraising strategies and climbed the Ride leaderboard. By year six, they had raised an astonishing \$1.5 million, with Nicholas setting an all-time individual fundraising record of \$311,000. "Once we found our momentum, we realized there was no limit to where we could go," he said.

"The ingredients of success are simply a clear vision and the ambition to go for it."

Since their first Ride, the Cycle Warriors have continued to raise more money each year. Combined with a significant philanthropic commitment from The Nicholas Fidei Foundation, the Cycle Warriors have contributed a remarkable \$5.5 million in total. In June of 2024, nearly 40 Riders strong, they geared up for a twelfth year. Their commitment remained steadfast, and they showed no signs of slowing down.

"Cancer has touched every family we know," Nicholas said. "We look forward to Ride weekend every year. It's such a special time for our team, our families and our friends."

Nicholas and his teammates have set an inspiring pace, motivating others and fuelling our Ride to Conquer Cancer aspirations. Together, we pedal towards a brighter future for all, united in our commitment to Conquer Cancer.





Early Detection Keeps Saving

Luana's Life

While every cancer journey is different, Luana Locke's is truly one of a kind. At the age of 25, while pregnant with her first child, Luana was diagnosed with breast cancer. That diagnosis triggered genetic testing which revealed even more devastating news: she had a rare hereditary disorder called Li-Fraumeni Syndrome (LFS), that comes with an almost 100% chance of developing cancer again in her lifetime.

"When I was diagnosed, it wasn't a stretch for me to think that my newborn would soon be left without a mother," said Luana. "No one in my family before me had survived their cancer diagnoses." Unfortunately, Luana lost her mother to breast cancer at a young age, followed by her sister, her brother, their aunt and a young nephew. "For me, learning I had LFS was more about making sense of it all; understanding there was a reason for all of these occurrences in my family. Despite the reality and statistics, my attitude toward survival has shifted significantly because of The Princess Margaret," she said.

Breakthroughs in early detection at The Princess Margaret and donor-funded medical research are the reason Luana has survived cancer six times. Since her initial diagnosis, she has faced sarcoma, lung cancer, thyroid cancer and skin cancer and, each time, the cancer was discovered in its earliest stages and successfully treated. Currently, she is living cancer-free.



"Early detection has the profound potential to find cancer sooner than ever before, including hereditary cancers that are too often overlooked," said Dr. Raymond Kim, Medical Geneticist and Director, Cancer Early Detection at The Princess Margaret. He has been Luana's physician for the past 10 years. "By using new approaches and technologies such as liquid biopsies, we can intervene earlier, develop more precise treatment plans and extend the lives of people facing a cancer diagnosis."

Dr. Kim, in collaboration with Dr. Trevor Pugh, Senior Scientist at The Princess Margaret, is leading **CHARM** (**C**ell-free DNA (cfDNA) in **H**ereditary **A**nd **H**igh-**R**isk **M**alignancies), an international study aiming to develop a new liquid biopsy test to detect tumours in patients with hereditary cancer syndromes like Luana's.

Liquid biopsies have already begun to transform health outcomes for thousands of cancer patients around the world. This innovative technique works by detecting circulating tumour DNA (ctDNA) – tiny fragments of cancer DNA that have been shed by tumours into a patient's bloodstream. Requiring only a blood draw, liquid biopsies allow clinicians to diagnose cancer earlier than ever before, and in a much less invasive way compared to traditional, surgery-based biopsies.

Thanks to this revolutionary breakthrough, Luana's story has been able to move from one of loss, uncertainty and suffering, to one of hope, trust and optimism. "I feel very strongly that I've been blessed to have the doctors that have treated me – Dr. Kim, in particular. They make me feel like they are fully committed to my long-term survival," said Luana. "I've been given access to tests that will detect my cancer at a very early stage. I'm one of the lucky ones."


